

RESOLUTION NO. 2023- 02

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE FORT MYERS BEACH MOSQUITO CONTROL DISTRICT ADOPTING THE TENTATIVE BUDGET FOR FISCAL YEAR 2023/2024, COMMENCING ON OCTOBER 1, 2023, AND ENDING ON SEPTEMBER 30, 2024; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, pursuant to Section 200.065, Florida Statutes, the Board of Commissioners for the Fort Myers Beach Mosquito Control District held a tentative public budget hearing on September 7, 2023, at 5:01 p.m., at 300 Lazy Way, Fort Myers Beach, Florida 33931, to adopt a tentative budget for the District's fiscal year commencing October 1, 2023, and ending on September 30, 2024.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners for the Fort Myers Beach Mosquito Control District, that:

SECTION ONE: INCORPORATION OF RECITALS

The recitals set forth above are true and correct and form a part of this Resolution.

SECTION TWO: AUTHORITY

The Board of Commissioners is authorized to adopt this Resolution by Florida law.

SECTION THREE: BUDGET

The Board of Commissioners does hereby adopt and set its tentative budget of estimated expenditures and revenue for the fiscal year commencing October 1, 2023, and ending on September 30, 2024, in the amount of \$984,420.00.

SECTION FOUR: SCRIVENER'S ERRORS

Sections of this Resolution may be renumbered or re-lettered and corrections of typographical errors which do not affect the intent may be authorized by the Board of

Commissioners, without need of public hearing, by filing a corrected copy of same with the County Clerk.

SECTION FIVE: CONFLICT

Any provision of any resolution or regulation which is in conflict with the provisions of this Resolution is repealed prospectively to the extent of such conflict.

SECTION SIX: LIBERAL CONSTRUCTION

The terms and provisions of this Resolution shall be liberally construed to affect the purpose for which it is adopted.

SECTION SEVEN: SEVERABILITY.

If any portion of this Resolution is for any reason held or declared to be unconstitutional, invalid or void, such holding shall not affect the remaining portions of this Resolution. If this Resolution shall be held to be inapplicable to any person or circumstances, such holding shall not affect the applicability of this Resolution to any other person or circumstances.

SECTION EIGHT: EFFECTIVE DATE.

This Resolution shall take effect upon the adoption of this Resolution by the Board of Commissioners.

The foregoing Resolution was offered by Commissioner St. John, who moved its adoption. The motion was seconded by Commissioner Joanne Semmer, and being put to a vote, the vote was as follows:




